

# **Alabama Mountain Lakes Association "Out of this World Road Trip Giveaway"**

## **Official Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN PRIZE. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.**

**1: ELIGIBILITY:** The Alabama Mountain Lakes Association "Out of this World Road Trip Giveaway" ("Giveaway") is open only to persons who, as of date of entry, are legal residents of one of the forty-eight (48) Contiguous United States or the District of Columbia, and at least 18 years of age or older (19 years of age or older in Alabama and Nebraska) at the time of entry. Employees, retirees, and agents of Alabama Mountain Lakes Association and each of their parents and affiliates, agencies, distributors, wholesalers and retailers, and members of such employees' immediate families and individuals living in the same household with such employees, are not eligible to enter or win.
