- 1. Identify partners, including yourself, who you recommend being considered as Board nominees. Only Visit Albuquerque partners in good standing are eligible to serve on the board. There are three open seats for the FY25 Board from the following industry categories:
  - Hospitality/Lodging w/15,000 feet of meeting space two seats
  - General Business one seat

One of the two Hospitality/Lodging seats and one General Business seat are held by incumbents who qualify for a second term.

2. Complete the online Nomination Form and attach a résumé for your candidate. When making your nomination, consider those you believe to be a strong representative of the above industry sectors.

Qualifications and Expectations for Board Directors:

- a) Business or organization must be a Visit Albuquerque partner in good standing;
- b) Passionate about Albuquerque, the destination;
- c) The primary decision maker of their company;
- d) Willing to serve on a high-functioning, working Board;
- e) Available for committee assignments, as needed;
- f) Able to attend Visit Albuquerque events;
- g) Available to attend a Board meeting on the fourth Tuesday of every other month (11:30 am - 1:30 pm) and one annual all-day board retreat;
- h) Desire to work hard toward the best possible leadership in the hospitality industry.
