

## Visit Anaheim's 100 Days Till Summer Challenge

### Official Rules

To enter this Sweepstakes, you must agree to and abide by these Official Rules.

1. **SPONSOR:** Anaheim/Orange County Visitor & Convention Bureau, a California non-profit mutual benefit corporation with offices at 2099 S. State College Blvd., Ste. 600, Anaheim, CA 92806 ("Visit Anaheim" or "Sponsor").
2. **ELIGIBILITY:** The Visit Anaheim's 100 Days Till Summer Challenge ("**Sweepstakes**") is open solely to legal residents of the United States. Employees of Visit Anaheim, or other companies associated with the promotion of the Sweepstakes, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, state, and local laws and regulations and is void where prohibited.
3. **SWEEPSTAKES ENTRY START/END DATES:** The Sweepstakes begins on [Friday, May 2, 2025] at [8:00 AM] PDT and ends on [Friday, May 16, 2025] at [11:59 PM] PDT (the "**Entry Period**"). All entries must be received during the Entry Period. Visit Anaheim's computer is the official clock for this Sweepstakes.
4. **HOW TO ENTER:** During the Sweepstakes Period, go to [visitanahaim.org/100DaysChallenge](http://visitanahaim.org/100DaysChallenge). Enter your first name, last name, and email then click the "Next" button, and submit the correct secret summer phase. Entries are limited to one entry per person. All received entries become the property of Visit Anaheim and will not be returned. Incomplete entries will be disqualified. Multiple entries by means of software-generated or other automated processes will be disregarded. Detection of said automated entry will lead to such entries being voided in Visit Anaheim's sole discretion. If there is a dispute as to any entry, the authorized account holder of the email account used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email account. Potential Winner may be required to show proof of being the authorized account holder.

Alternate entries post-marked after May 16th will not be entered into this sweepstakes. Winners will be announced on or about [May 28, 2025].

5. **DRAWING:** On or about Monday, May 26, 2025, Visit Anaheim will select three potential winners, with 100% correct entries, in a random drawing from all entries received. All entries will be assigned a number, and a random number generator will be used to select the winner. The odds of being selected depend on the number of entries received.
6. **WINNER NOTIFICATION:** The potential Sweepstakes winners ("**Potential Winners**") will be notified on May 26, 2025, by Visit Anaheim via email to his/her email account. Potential Winners will be required to reply to the received direct message with the Potential Winners' email address within 24 hours to claim their prize. All Potential Winners must respond to Visit Anaheim's notification within 24 hours from the date of notification. If a Potential Winner fails to respond to the notification within the specified time, or if a Potential Winner is ineligible per winner verification process conducted by Visit Anaheim, he or she will be disqualified and forfeit any rights to his/her prize and the next runner-up entrant may be eligible for the given prize at Visit Anaheim's discretion. After initial contact has been made, subsequent communication may take place via email by Visit Anaheim. The first randomly selected winner will receive one grand prize, which includes (4) 3-Day Park Hopper tickets to the Disneyland Resort, (4) Los Angeles Angels tickets (1) \$100 Visa Spending Card (1) 2-night stay at Howard Johnson Anaheim Hotel and Water Playground, (4) general seating on Catalina Express. Parking is not included for any event/game tickets, attraction/theme parks, transportation, or hotel stay. Complimentary hotel stays include room and tax only; subject to availability and an advanced reservation is required. Theme Park and entertainment tickets are subject to availability and blackout dates, and park entrance is subject to capacity. Disney Park Hopper admission requires advanced reservation through the Disney reservation system. Catalina Express tickets are for mid-week travel only (Monday-Thursday). Theme Park tickets expire on December 31, 2025. Hotel stay expires on February 28, 2026. Catalina Express tickets expire on December 31, 2025. Visa Gift Card subject to separate terms

& conditions. Tickets to the Los Angeles Angels are subject to availability for the 2024/2025 season. The total prize package is worth approximately \$5,750.

The second randomly selected winner will receive a separate prize package which includes (4) one-day, general water park admission to Great Wolf Lodge, (4) one-day general admission tickets to Knott's Berry Farm, (2) Anaheim Ducks tickets, and (1) \$100 Visa Spending Card. Parking is not included for any event/game or attraction/theme park. Water park admission at Great Wolf Lodge is for the water park only and does not include hotel stay. Water park, theme park, and game tickets are subject to blackout dates and availability, and park entrance is subject to capacity. Great Wolf Lodge Waterpark admission is based upon availability and advanced reservation is required. Tickets to the Anaheim Ducks are subject to availability for the 2025/2026 season. Visa Gift Card is subject to separate terms & conditions. Waterpark tickets expire on December 30, 2025. The total prize package is worth approximately \$1,200.

The third randomly selected winner will receive a separate prize package, which includes (2) general Anaheim Ducks tickets and (1) book, *100 Things to Do in Anaheim Before You Die*. Parking is not included for any event/game or attraction/theme park. Tickets to Anaheim Ducks are subject to availability and for the 2025/2026 season. The book, *100 Things to Do in Anaheim Before You Die* is by author Melanie Walsh. The total prize package is worth approximately \$450.
