

# **Anchorage AFN Sweepstakes Rules**

## **Anchorage Sweepstakes Rules & Eligibility**

1. NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR TO WIN.
2. The Anchorage AFN Sweepstakes (the "Sweepstakes") is open only to persons who are 18 years of age or older who will attend the 2021 Alaska Federation of Natives convention in Anchorage, Alaska as a delegate, and have a valid e-mail address as of the Start Date. Sweepstakes is void in New York, Florida, and wherever prohibited by law.
3. Sweepstakes is limited to one entry per person. Any person who attempts to participate with multiple email and/or street addresses, under multiple identities or using any device or artifice to enter multiple times will be disqualified.
4. The Sweepstakes Sponsor is the Anchorage Convention & Visitors Bureau (ACVB) DBA Visit Anchorage, having an address of 524 W. Fourth Avenue, Anchorage Alaska 99501-2212.
5. The Sweepstakes begins at 12:00 midnight ADT on September 21, 2020 (the "Start Date") and ends at 11:59:59 p.m. AST on October 31, 2020 (the "End Date"). The odds of winning depend upon the number of eligible entries received.

6. One grand prize winner will receive:

If an Alaska resident: round trip airfare for two to/from any Alaska cities served by Alaska Airlines, four nights accommodation in Anchorage, Alaska (during the AFN convention), and a \$100 gift card for expenses.

If a non-Alaska resident: round trip airfare for two to Anchorage, Alaska from the nearest U.S. city to the winner's residence that is directly served by Alaska Airlines, four nights accommodation in Anchorage, Alaska (during the AFN convention), and a \$100 gift card for expenses.

Airfare or other transportation to/from the Alaska Airlines gateway city in which prize starts/ends, baggage fees, and upgrades are not included. Local transportation, meals, and gratuities are the responsibility of the winner, as are all hotel charges other than basic room fees.

7. A second prize winner will receive:

Four nights accommodation in Anchorage, Alaska (during the AFN convention), and a \$100 gift card for expenses.

Airfare or other transportation to/from Anchorage in which prize starts/ends, local transportation, meals, and gratuities are the responsibility of the winner, as are all hotel charges other than basic room fees.

8. Restrictions: Blackout dates and restrictions apply. Advance notice required. Contact Visit Anchorage for more information.
9. Travel must occur between October 1, 2021 and October 31, 2021. Sweepstakes Sponsor is not responsible for delayed, cancelled, or missed flights. No amenities or accommodations will be provided other than those listed in these Rules. Applicable taxes and all other expenses incurred in connection with redemption of any prize are the responsibility of the winner. The grand prize is valued at approximately \$3,000.
10. Prizes may not be redeemed for cash or substituted for any other prize by the winner. Visit Anchorage reserves the right to substitute a prize of equal or greater value in its sole discretion.
11. **HOW TO ENTER:** Visit [www.Anchorage.net/AFN](http://www.Anchorage.net/AFN) and complete the official entry form. All online entries must be received by the Sweepstakes end date for inclusion in the drawing. No form of entry other than that specified herein is permitted. Use of automated, programmed, robotic or like forms of entry is prohibited. By entering the Sweepstakes, all entrants that provide an e-mail address agree to receive at least one e-mail from Visit Anchorage.
12. In case of dispute, electronic entry will be declared made by the authorized account holder of the submitted e-mail address as of the time of entry. An authorized account holder is the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
13. Visit Anchorage is not responsible for telecommunications, network, electronic, technical or computer failures of any kind, including any which may affect your entry or the Sweepstakes. Visit Anchorage is not responsible for lost, stolen, misdirected, mutilated, late or illegible entries. Entries that are generated by a script, macro, or other automated means are prohibited and such entries and/or those otherwise not in compliance with these Official Rules are disqualified. All entries received by facsimile are disqualified. Visit Anchorage shall have the absolute right to determine in its sole discretion if an entry is in full compliance with these Official Rules without notice to the person attempting to enter.

By entering the Sweepstakes, each participant warrants that he or she has read and agrees to abide by these Official Rules and that he or she is not prohibited from participating in the Sweepstakes. Each participant agrees to release, discharge, indemnify and hold harmless Visit Anchorage and its affiliates, employees, officers, directors, agents, sponsors, prize suppliers, and affiliated advertising and promotion agencies from any and

all liability arising from or related to the Sweepstakes, including without limitation, personal injury, death, property damage, or claims based on publicity rights, defamation, or invasion of privacy.

In the event a winning entry is discovered by Visit Anchorage to be invalid for any reason whatsoever, or the person who submitted the winning entry fails to comply with these Official Rules prior to delivery of the prize as determined by Visit Anchorage, the prize may be forfeited and awarded to an alternate winner.

If by reason of a printing or other error, more prizes are claimed than the number set forth in these Official Rules, all persons making purportedly valid claims will be included in a computerized random selection to award the advertised number of prizes available. No more than the advertised number of prizes will be awarded.
19. Attempts to notify the winner will be made only by e-mail to the e-mail address submitted with the winning entry. Notification will occur within thirty (30) days of the winner's selection. Visit Anchorage is not responsible for telecommunications, network, electronic, technical or computer failures or delivery problems of any kind. If Visit Anchorage is unable to make contact with the winner within thirty (30) days after Visit Anchorage first attempts to notify the winner, or if the winner fails to claim the Prize upon notification, the Prize may be forfeited in the discretion of Sweepstakes Judges and awarded to an alternate winner.
