#### **Regular Business:**

### **June 2021 Financial Statements**

Director of Finance Mindi Baumann reviewed the June 2021 Financial Statements. We had one event in June. Direct Event Income for the month was \$6,366. Convention Services generated \$18,057 in Income in June. Other Income of \$1,663 was from recycling. Adjusted Gross Income was up \$24,923 Actual vs Budget. Salaries for the month were up due to the 2019 and 2020 cost of living adjustments. Repairs and Maintenance were up this month due to Cooling Tower repairs and Chiller Maintenance. COVID-19 Expenses this month were \$1,839 for the plexiglass barriers for the box office and concessions areas. Bleacher Revenue of \$3,500 is now being moved above the line to Convention Services. Net Income for the month was up \$24,428 Actual vs Budget. Commissioner Ross asked about the payment methods used for Peoria Expo. Director of Finance Mindi Baumann explained that most of the clients are invoiced for their events, but some do pay cash at the time of their event.
