### June 2019 Financial Statements

Danette Snopek is out on emergency medical leave. Rik Edgar reported that in June 2019 the adjusted gross income has improved by more than \$1 million vs FY2018 YTD. The Convention Center served as host to two banquets, Thomas Jefferson and Central IL Preps. Total attendance was 1,065. Spa's and More was a consumer show which held its inaugural event in the E-halls on June 14-16. PEO Sisterhood, IL Great Rivers, and IL Assoc of Fire Protection also hosted in the exhibit hall space. Total attendance was greater than 6,000. In the Arena, the Carden Circus hosted 2,155 guests on June 8<sup>th</sup>. The remainder of the month was dedicated to maintenance projects including resurfacing and painting the Bradley University

basketball floor. The theater also exceeded revenue expectations with a Styx concert on June  $27^{th}$ .

Rik also explained the variance with F&B. There was an issue with duplication of inventory that was rectified in June. This was a system error not an accounting error.

### Fiscal Year 2020 Budget

The committee would like to see the budget updated with numbers from the rolling forecast for projections vs. budget. Also requested would be a 90% TRF Document updated for every meeting. There was also discussion on what figure was used for HRA - \$700,000, the term remaining on the PNC loan – 3 years, and the term remaining on the Rivermen contract – this is the last season. Robert Manning is also requesting the next version of the budget be presented on blue paper.
