## **August 2023 Financial Statements**

Director of Finance Mindi Baumann reviewed the August 2023 Financial Statements. The events for August are final, but we are still working on the capital projects. In August we had 17 event days with an attendance of 23,283. We had one funded event which was Highway Township Officials. Successful events included: Frankie Valli, RuPaul's Drag Race, Pat Benatar, Highway Township, St. Jude, Growmark, and Bandai-One. Ticket Rebates were up compared to budget as well as Convention Services and Parking. Adjusted Gross Income was up \$174,887 Actual vs Budget. Contracted Services were up due to July and August IT services being recognized. General and Administrative Expenses were up and included the ASM Training

Academy, the purchase of additional Square terminals, and the inventory over/short. Operational Supplies included the purchase of uniforms, ADA signage, custodial supplies, and building painting. We received the July and August HRA this month. Net Income for the month was up \$758,315 Actual vs Budget.

The Operating Cash is not below the one million dollar threshold.
