Regular Business:

September 2020 Financial Statements

Mindi Baumann reviewed the September 2020 Financial Statements. Some expenses were incurred this month due to the cancellation of the Cole Swindell concert. Advertising income was up due to the renegotiating of contracts because of COVID-19.

Salaries and Benefits are consistent with the current mitigation plans. Insurance Expense is up because it was budgeted with the reduced rate. The expense will be adjusted when the credit is received. Staff is working with other buildings to review our building rates and determine any adjustments that might be needed. Due to COVID-19 our physical inventory is still being reviewed for any items that will soon have expired dates. Staff is working on putting together a list of our COVID-19 related expenses. Chairman Manning asked about our 90 Day Cash Flow. Rik Edgar stated we have received approval for a second COVID-19 related grant. The expenses for the second grant must be submitted before the end of the year. Director of Operations Will Kenney submitted the first round of expenses for reimbursement this week and will be submitting a second round of expenses soon. Commissioner Manning stated that of the \$4 million dollars that was approved to the Peoria Civic Center from the City, \$2 million dollars of it was received from the City in early October. Chairman Manning stated all other options were exhausted before agreeing to the City option.

Revised FY21 Budget

The Revised FY21 Budget was presented by General Manager Rik Edgar to the City Council and approved. The commissioners discussed the additional funding and additional expenses. Staff must continue to be fiscally responsible and be able to justify where money is being spent, especially during this unprecedented time of COVID-19.

Old Business:

Accounts Receivable

General Manager Rik Edgar discussed our outstanding Accounts Receivable accounts. Collection options were discussed.
