Call to Order

Finance Meeting Minutes

Paul DiGiallonardo made a motion to approve the minutes from the September 20, 2016 meeting. It was seconded by Robert Manning. The motion was passed unanimously.

New Business -

Agenda Format Changes

Danette Snopek reported that the format changes on the Agenda were per the request of Dave Stuckel.

September 2016 Financial Statements

Danette Snopek reported there were 35 event days versus a budget of 42. Event income was under budget by \$10,632. In the Convention Center, two meetings took place versus six budgeted and nine banquets took place versus ten budgeted. The LTD convention came in over budget and one convention that was budgeted that did not occur. Other Income was under budget due to the non-renewal of one of the suite contracts. Beau is working on a contract for a new suite holder. Wages/benefits, electricity, and heating fuel were under budget for the month. This is the fourth month the City of Peoria is adjusting the HRA subsidy to reflect the over payment from February through May. The reduction is \$40,040 each month. Pratima Gandhi asked what caused the event income to be under budget and

what we are anticipating for the coming year. Anne reported on concerts for FY17. The mix of concerts we get and the day of the week have a direct effect on the F&B per caps. One concert in September met budget and two did not. Anne discussed some of the types of concerts that we are working on. A question was asked about the Ticket Escrow Account. The balance is currently high due to Wicked and all ticketed events sold through Ticketmaster.

Siemens Maintenance Agreement

Will Kenney presented a \$28,220 annual three year maintenance agreement with Siemens Building Technologies for our building HVAC and lighting control systems. This is a sole source vendor. It is to be put on the agenda for the next PCCA Meeting. Staff is to check with Dave Stuckel to determine the threshold of what the Finance Committee is allowed to approve.
