General Manager Rik Edgar submitted the venue report. The Lindsey Stirling concert is a Peoria favorite and she performed for her third time this year. Our annual PNC Kids NYE Countdown & Fireworks had more than 2,500 in attendance with 20+ vendors and community partners. Book of Mormon did very well and set a new venue standard as the highest grossing two-night Broadway performance. The Nutcracker hosted more than 6,700 guests. Despite our tenant sports numbers being down from last season, Rivermen hosted 6 games and Bradley hosted 4 contests. The convention center hosted the 42nd Annual Greater Peoria Farm Show and another Top Cut Events Bandai Tournament.
