- Bayfield Chamber staff reserves the right to determine if a business fits under any given category on chamber marketing materials.

Lodging Membership Policy

- Lodging owned by a single business may be combined in order to obtain membership benefits
 under the name of the business holding the membership if they are located in the same building or
 complex.
- Lodgings managed and not owned by companies cannot be combined in order to gain membership benefits
- All lodging members must be in compliance with all local, county and state requirements. If the Bayfield Chamber and Visitor Bureau is notified that you are not in compliance you will be notified and removed from marketing materials until you are compliant.
