## FY20 Resort Tax App – Letters and In-Person Show of Support

Candace discussed the status of the current FY20 Resort Tax application that was submitted on behalf
of VBS. Three Resort Tax board members will be in attendance at the Marketing Outlook Luncheon,
in addition to the new District Manager. Strauss encouraged VBS Board members to submit letters
of support and attend the Q&A session respresenting their individual businesses. A conversation
prompted by Dan was had discussing the potential of a TBID and if it would make sense for VBS to
apply for one down the road.

## FY20 Board Nominations, Elections, Officers; NEW Staff

- Candace shared that VBS has hired a new Visitor Services Manager who will oversee the daily office duties and assist with the visitor information center.
- Ennion Williams has chosen not to run for re-election to the VBS Board for another three year term, but will continue to serve on the Events Committee. There are now three open seats on the VBS Board. Tim is seeking re-election to for a new three year term. Dan made a motion to re-elect Tim to the board, Krista seconded and the motion passed unanimously.
- Ryan Hamilton resigned as the Chair, but will remain on the board of directors until the end of his term in 2020. Tim expressed interest in serving as the new Chair, Dan said he would continue to serve as the Vice Chair and Ryan Kunz said he would fill Tim's previous role as the Secrectary/Treasurer for FY20. A motion was made by Julie to elect the FY20 slate of officers: Tim Drain chair, Dan Martin Vice Chair and Ryan Kunz Secretary/Treasurer. Justin seconded the motion and it passed unanimously.

## **VBS Membership per IRS Rules & Regulations**

• Emilie gave an overview of the Host Week program for the summer 2019 season. The passbook will be similar to years past with approximately fifteen Big Sky businesses having offered deals in this year's book. VBS will be educating businesses to provide these books to new, frontline employees in Big Sky. No businesses outside of the BSRAD will receive passbooks at this time.

## **Summer 2019 Research – Destination Analysts**

This summer, Destination Analysts will be in Big Sky conducting visitor intercept surveys to create a
visitor profile, to gather a baseline knowledge of Big Sky as a destination from the traveling public
and to identify pain points from touch down to take off for visitors into Bozeman Airport, Big Sky and
West Yellowstone.

## NEW - 2019/2020 Official Visitors Guide

• The new OVG will be finalized by Memorial Day weekend and out for public distribution the second week of June. The guide will be distributed throughout Bozeman and Big Sky as well as to a five state region including Montana, North Dakota, Idaho, Wyoming and Utah.

## IMPROVED visitbigsky.com website - Wild Blue | Rad Smith Illustrations - Maps

• The VBS website has just undergone some aesthetic and functional improvements and is now even more user friendly for both visitors and the VBS marketing team. Rad Smith was contracted to create four maps for Big Sky including a destination overview and three more detailed maps highlighting the canyon, meadow and mountain areas. These maps are set to be completed throughout the summer and will be available to the public and local businesses.

## **Summer 2019 Marketing Campaign**

- VBS has hired Hoffman York, MOTBD's advertising agency, via a joint venture with funds from the state, to lead its effort in its summer marketing campaign focused again on the niche market of hiking. They will also support a second niche campaign in the fall targeting the hunting market.
- Destination Think is currently running a spring warm up campaign for the hiking market using collateral from last year's influencers trip.
