



## Visit Bloomington Contest Terms & Conditions

### OFFICIAL RULES

1. **Eligibility:** Contest is open to anyone who signs up on the contest page and is 18 years of age (unless stated otherwise) as of the date of entry. Visit Bloomington's employees, community partners, or others closely affiliated with the organization are not eligible to participate in the contests.
2. **Agreement to Rules:** By participating, you agree to be bound by these rules and meet the eligibility requirements mentioned above. Further, you agree to accept the decisions made by Visit Bloomington as final and binding as it relates to the content.
