



Onsite COVID19 Testing Options

OTC Rapid Antigen*

\$875/box (box contains 25 tests)

- Client provides CSV file of testing participants to upload in P1UC testing platform
- Client to identify administrators for P1UC testing platform (HIPAA information)
- Participants to create account and provide consent in P1UC testing platform
- Client collects kits at designated P1UC location or arranges drop-off (extra charge)
- Client must collect kits at designated P1UC site
- Results must be entered in P1UC testing platform by client administrators
- Client must email P1UC with positives: nurseline@p1uc.com (within 24 hours)+
- P1UC to call positives, provide consultation on isolation

CLIA waived Rapid Antigen*

\$625/box (box contains 25 tests)

- Client provides CSV file of testing participants to upload in P1 testing platform
- Client to identify administrators for P1UC testing platform (HIPAA information)
- Participants to create account and provide consent in P1UC testing platform
- Client must collect kits at designated P1UC site
- Results must be entered in P1UC testing platform by client administrators
- Client must email P1UC with positives <u>nurseline@p1uc.com</u>
- P1UC to call positives, provide consultation on isolation (within 24 hours)+
- Client must have CLIA waiver for each location of testing if testing in gym, town hall, EACH location requires a CLIA waiver. Client to provide CLIA # to P1UC

CLIA waived Rapid Antigen with P1UC staff for collections*

\$1375/box (box contains 25 tests)

- Client provides CSV file of testing participants to upload in P1UC testing platform
- Client to identify administrators for P1UC testing platform (HIPAA information)
- Participants to create account and provide consent in P1UC testing platform
- P1UC to provide kits/PPE/supplies and staffing for collections
- P1UC staff enters results in P1 testing platform
- Client must email P1UC with positives <u>nurseline@p1uc.com</u>
- P1UC to call positives, provide consultation on isolation (within 24 hours)+
- Client must have CLIA waiver for each location of testing if testing in gym, town hall, EACH location requires a CLIA waiver.
- Client to provide CLIA # to P1UC

<u>QuickVue SARS Antigen Test | Quidel</u> QuickVue (quickvuetraining.com)

*Antigen kits cannot be separated as only 1 vial for testing solution per box







PCR with P1UC staff for collections

\$80 per participant

- Client provides CSV file of testing participants to upload in P1UC testing platform
- Client to identify administrators for P1UC testing platform (HIPAA information)
- Participants to create account and provide consent in P1UC testing platform
- P1UC to provide staffing, testing kits/PPE/supplies and provider order for onsite testing
- Results in P1UC testing platform
- P1UC to call positives, provide consultation on isolation (within 24 hours)+
- Participants can download/print results
- Results 24 -36 hours (time starts when samples reach lab)+
- Minimums apply

PCR with no P1UC staff for collections (drop-off/pick up)

\$60 per participant

\$250 one-time fee: observed swab training (if needed)

- Client provides CSV file of testing participants to upload in P1UC testing platform
- Client to identify administrators for P1UC testing platform (HIPAA information)
- Participants to create account and provide consent in P1UC testing platform
- P1UC to provide testing kit(s), supplies and provider order for testing
- Client collects kits at designated P1UC location or arranges drop-off (extra charge)
- Client arranges pick-up of samples with P1UC
- Client oversees observed swabbing process
- Results provided in P1UC testing platform
- P1UC to call positives, provide consultation on isolation (within 24 hours)+
- Participants can download/print results
- Results on average 24 -36 hours (time starts when sample reach lab)+
- Minimums apply
