It was organized in 1969 to raise funds from the capital markets to supplement the loan programs for electric cooperatives offered by the Rural Utilities Service (RUS), previously Rural Electrification Administration (REA). Today, CFC is the premier market lender for the nation's electric cooperatives. CFC provides financing and related services to RUS borrowers and non-borrowers alike. Their loans help members acquire, construct, and operate the utility infrastructure needed to deliver services that improve the quality of life in rural areas. CFC also provides credit enhancements, including letters of credit and guarantees of debt obligations, for their members.

About the Meeting:

Created and owned by America's electric cooperative network, CFC—a nonprofit finance cooperative with approximately \$25 billion in assets—provides unparalleled industry expertise, flexibility and responsiveness to serve the needs of our member-owners. Together, CFC and its affiliates, the National Cooperative Services Corporation (NCSC) and the Rural Telephone Finance Cooperative (RTFC), provide financing to member organizations and affiliates in 48 states, the District of Columbia and two U.S. territories. The CFC Forum is the annual conference on issues and challenges facing the electric cooperative network.
