#### IV. 5150' WINTER FESTIVAL

- The festival kicks off Saturday, January 27, 2024 with Robert Burns Day at Frontier Brewing.

- Snow sculpting competition
  - David Street Station.
  - The snow blocks will be packed on Monday, January 29, 2024.
  - Four teams of four are entered into the event.
  - Competition starts Thursday, February 1, 2024.
- Casper International Film festival
  - 30+ films will be shown at Frontier.
  - Festival will run Thursday, February 1, 2024 through Sunday, February 4, 2024.
- Winterfest Photography Exhibition
  - 123 photo submissions.
  - 100 will be selected and exhibited at the Nicolaysen Art Museum.
  - Judging will take place on Friday, January 26.

**VI. CASH BASIS ACCOUNTING**

Information only, no board action is required.

- Visit Casper will be moving to a cash basis accounting system.
  - Roxy from Skogen & Cometto suggested moving to cash basis accounting at the November board meeting.
    - Simpler statements.
    - Easier to read.
    - More simplistic.
  - Can switch over within the current FY.
- Visit Casper currently has a good procedure in place.
  - Continue to track information until the FY24 audit is complete.

**VII. 2021 MASTER PLAN PROGRESS REPORT**

- In 2021, engaged stakeholders for the Visit Casper road map for the future.
- In June 2023 Visit Casper brought those stakeholders back to the table for a progress report.
  - Progress report is posted to the website.
- Updates from 2021 to 2023 are impressive and include:
  - Destination Marketing Fee implementation with hotels.
  - Destination development grant at the state level with access to \$600,000 every two years.

- Engaged with sustainable strategies which opens Visit Casper up to access of more Federal grants.
- Created the Natrona County Improvement Committee.
- Ford Wyoming Center study with economic impact numbers and the expansion of the locker rooms.
- Created new event – 5150' Winterfest.
- Pivoted from the Business Challenge to the Marketing Co-op.
- Purchase of Visit Casper bus.
- Implementing way-finding signage.
- Created a group with Fly Casper Alliance to work with the Maximum Revenue Guarantee (MRG).
- Trail expansion.
- Two new assets - Wyo Ranch and hotel properties.
- The lodge renovation.

#### VIII. **CENTRAL WY SHOOTING RANGE**

- SF169 – legislators allocated \$10M and a task force to complete the construction of a shooting complex within the state of Wyoming.
- Visit Casper has led a group since August to meet on what a shooting complex in Casper would look like, and to engage stakeholders.
- The task force established March 1, 2024 as the deadline to submit a letter of interest.
- Asking for support from local municipalities, the county, and community stakeholders.
- City of Casper has engaged with the University of Wyoming to conduct an economic impact study on the shooting range and what that could look like for Casper.
- Visit Casper, Advance Casper, the City of Casper, and Natrona County are each contributing \$5,000 to offset the cost of the \$20,000 study.
- One page result sheet will be submitted with the letter of interest.
- Task force committee members are going to the Cameo shooting complex in Colorado for a site visit of that facility to get information on a timeline, the work force, job creation, events they were able to secure, and the impact on the community.

Moved by Ms. Powers, seconded by Ms. Engebretsen, carried without dissent that the NCTTC support the Central Wyoming Shooting Range location in Natrona County.
