V. **LEGISLATIVE UPDATE**

Ms. Kaufman introduced Chris Brown from the Wyoming Lodging and Restaurant Association. Mr. Brown reviewed the status of a few key bills that would impact the tourism industry. He explained that there haven't been as many calls to action this

session, but he had some initial concerns over attacks to the statewide and local option lodging tax that were fortunately tabled. He will keep the industry in the loop on any new major developments.

**VI. FORD WYOMING CENTER UPDATE**

Ms. Kaufman turned the floor over to Brad Murphy who updated the board on the Ford Wyoming Center. Mr. Murphy shared attendance numbers for recent events and highlighted that there has been an increase in traffic since the mask mandate has been lifted. He proceeded with an update about upcoming events and his optimism for the future. He anticipates the Ford Wyoming Center will be open with no restrictions starting May 1, 2021.

**VII. PROUD TO HOST THE BEST (PTHB) UPDATE**

Ms. Kaufman asked Jim Ruble to give an update on Proud to Host the Best. Mr. Ruble informed the Visit Casper board that there have been some changes to the structure and board. He explained that there has been some turnover and that Visit Casper retained Crowley Fleck to re-write the bylaws and to draft an MOU between Visit Casper and PTHB for contract staff. The board will identify priorities in the coming weeks which will include fundraising, organizational structure, and awareness for the entity.

**VIII. OUTDOOR REC COUNCIL UPDATE**

Ms. Kaufman asked that Erik Aune speak to what has been going on with the potential Outdoor Rec Council. Mr. Aune informed the board that he has a group that is working on maximizing the potential of the outdoor recreation space in Natrona County to bolster our inventory and put us on the map. Ms. Kaufman added that one of the recommendations is to create a joint powers board and to possibly co-fund a dedicated position to develop that outdoor space. Mr. Aune added that there currently isn't a formal structure, but they are working to create the infrastructure moving forward.
