IV. BRAND LAUNCH PARTY – DECEMBER

VI. TRANSPORTATION OPTIONS

Mr. Rudloff, the CEO of Visit Cheyenne, called in and shared the history of the trolley system in Cheyenne. Visit Cheyenne currently operates 4 trolleys that are available 7 days a week from May – September. The trolleys are used for conventions, charters and to provide community tours. Currently, ridership is around 22,000 annually and the split is 50/50 between tours and charter business. The transportation committee will meet in the next 30 days and Ms. Kaufman will reach out to Mr. Rudloff after the first of the year to see if he'd be interested in consulting on a pilot program.

VII. MARKET SEGMENT UPDATE

In early 2019, the Natrona County Travel & Tourism Council made the strategic decision to move away from creating events which included the Cowboy State Games. In November, the National Congress of State Games awarded membership to the Gillette CVB in conjunction with TBH. Ms. Kaufman is working with Mrs. Silvernell, Executive Director of the Gillette-Wright Convention & Visitors Bureau, on the transition plan including owned assets. Ms. Kaufman anticipates the transition will be complete by the end of 2019.
