## **OFFICIAL RULES**

Follow Visit Cedar Park Texas on Facebook or Instagram and tag a friend in the comments section of the original post. Already following? Not a problem, just tag a friend in the comments. You can tag as many people as you like, but your name will only be entered once for the prize drawing. Entries must be received by Tuesday, August 8, 2023 at 11:59PM Central Time to qualify. Only one winner from either Facebook or Instagram will win. This contest is subject to federal, state, and local laws and regulations, as well as the following Official Rules:

- 1. Eligibility. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Cedar Park Rodeo at the H-E-B Center ("the Contest" or "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. All entries must be received by 11:59PM Central Time Tuesday, August 8, 2023. - **6. Winner Selection.** The winner will be selected using a random number generator by the Visit Cedar Park Texas team based on the Rules of Entry listed below. Odds of winning depend upon the number of entries received. Winner will be notified on the Visit Cedar Park Texas Facebook or Instagram Page and via direct message to the account they commented with on Tuesday, August 8, 2023 by 5PM Central Time. Winner will have until Thursday, August 10, 2023, at

- 11:59PM Central Time to claim prize. Instructions for claiming prize will be included in the direct message sent to the winner (this is to help insure identity of person claiming prize).
- **7. Rules of Entry.** Follow the Visit Cedar Park Texas Facebook Page or Visit Cedar Park Texas Instagram Page and tag a friend in the comments section of the original Facebook or Instagram post. Only one (1) entry per participant. By entering you are agreeing to allow Visit Cedar Park Texas to use any content submitted for the contest and are releasing publicity rights for said content. Facebook and Instagram do not endorse, administer, or sponsor the Contest, and is not in any way associated with this Contest and is released from any responsibility to entrants or participants.
- 8. General Conditions. In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Contest and, in the event of termination, award the prize at random from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. connection with the Contest, including, without limitation, errors that may occur in the administration of the Contest, the announcement of the winner, the cancellation or postponement of the event; if applicable, the incorrect downloading of the application, the processing of entries, or in any Contest-related materials; or (e) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Contest or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Disputes.** Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in Williamson County, Texas. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants rights and obligations, or the rights and obligations of the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of Texas, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than Texas.
