



# CORPUS CHRISTI

## TOURISM GRANT PROGRAM

### GRANT PROGRAM OVERVIEW

**Purpose of the Grant** To provide financial support to eligible businesses, including new businesses, that offer a unique and compelling visitor experience in Corpus Christi, and thereby increase tourism in the city.

**Type of Grant** Matching Grant

**Grant Amount** Up to \$5,000 per business

**Total Funds for the Program Year** \$50,000

**Eligible Businesses** Tourism-facing businesses that offer a visitor experience in Corpus Christi, such as tours, attractions, museums, galleries, restaurants, and other businesses that serve to enhance the visitor experience. Both existing and new businesses are eligible to apply.

#### Eligibility Criteria

- Must be registered with the City of Corpus Christi
- Must provide a detailed project proposal of the proposed new visitor experience, outlining the intended use of the grant funds, including a budget and timeline for the project
- New businesses must have a business plan and a clear strategy for attracting tourists to their business

**Application Process** Eligible businesses can apply for the grant program by completing an online application form on the Visit Corpus Christi website and submitting the completed application form to [admin@visitcorpuschristi.com](mailto:admin@visitcorpuschristi.com).

### **Evaluation Criteria**

- Quality and innovation of the new visitor experience offered by the business
- Feasibility and impact of the proposed project
- Ability of the business to successfully implement the project
- Potential to increase tourism in Corpus Christi
- Potential to increase visitor spending in Corpus Christi

**Grant Disbursement** Grant funds will be disbursed to successful applicants on a matching basis. This means that the business will need to match the grant amount with their own funds or in-kind contributions. The business will need to provide documentation of the matching funds or in-kind contributions before the grant funds are released.

**Reporting Requirements** Successful grant recipients will be required to submit a final report on the project, including an evaluation of its impact on the visitor experience in Corpus Christi, a financial report, and a narrative report detailing the successes and challenges faced during the project.

**Acknowledgement of Support** Recipient Organization agrees to publicly acknowledge the support of Visit Corpus Christi in all project-related communications, both online and offline. This includes, but is not limited to, press releases, social media posts, website content, and signage.

## **FREQUENTLY ASKED QUESTIONS**

### **Q: What is the purpose of the grant?**

**A:** The purpose of the grant is to provide financial support to eligible businesses that offer a unique and compelling visitor experience in Corpus Christi, and thereby increase tourism in the city.

### **Q: What type of businesses are eligible to apply for the grant?**

**A:** Businesses that offer a visitor experience in Corpus Christi, such as tours, attractions, museums, galleries, restaurants, and other businesses that cater to tourists. Both existing and new businesses are eligible to apply with higher priority going to new and recently started businesses.

### **Q: How many grants will be awarded?**

**A:** The number of grants awarded will depend on the number of eligible applications received and the availability of funds. The total funds available for the program year are \$50,000.

### **Q: Is there a matching requirement for the grant?**

**A:** Yes, the grant is a matching grant. This means the business must match the grant amount with its own funds or in-kind contributions.

**Q: How do I apply for the grant?**

**A:** Eligible businesses can apply for the grant program by completing an online application form on the Visit Corpus Christi website.

**Q: What are the eligibility criteria for the grant?**

**A:** Eligible businesses must be registered with the City of Corpus Christi and provide a detailed project proposal of the proposed new visitor experience, with an outline of the intended use of the grant funds, including a budget and timeline for the project. New businesses must have a business plan and a clear strategy for attracting tourists to their business.

**Some examples of visitor-facing experiences that an existing business could apply for are:**

- Developing a guided tour or audio tour that provides visitors with an immersive and engaging experience. For instance, a walking tour that highlights the history and unique features of a local neighborhood or attraction.
- Creating a new interactive experience or exhibit at an existing attraction that increases visitor engagement and enhances their experience. For instance, adding a virtual reality experience or interactive game.

Overall, the key is to identify projects that will have a lasting impact on the visitor experience, while still being feasible within the budget and resources available.

**Q: How will my application be evaluated?**

**A:** Applications will be evaluated based on the quality of the visitor experience offered by the business, the feasibility and impact of the proposed project, the ability of the business to successfully implement the project, and the potential to increase tourism in Corpus Christi.

**Q: When will I find out if I received the grant?**

**A:** Applicants seeking funding must submit an application online using the Corpus Christi Tourism Grant application. Applications from the preceding quarter will be reviewed by the Executive Leadership Team and considered during quarterly review periods in: October, January, April, July.

**Q: What are the reporting requirements for the grant?**

**A:** Successful grant recipients will be required to submit a final report on the project, including an evaluation of its impact on the visitor experience in Corpus Christi, a financial report, and a narrative report detailing the successes and challenges faced during the project.






