LOCAL NEWS



- In November, Denver City Council approved an <u>increase in the citywide</u>
 <u>minimum wage</u> that went into effect on January 1, 2020. Denver is the first
 municipality to increase its local minimum wage as the result of a measure
 approved by the Colorado legislature in 2019.
- VISIT DENVER joined with public, private and philanthropic partners to announce <u>support for expanded day shelter options and services</u> as well as bridge housing.
- The draft RFP for the National Western Center's (NWC) "Triangle Project", which will complete the redevelopment of the NWC including a 10,000 seat arena and expo hall, has been released.
- There are several important updates regarding initiatives in the <u>Denver</u> <u>Tourism Roadmap</u>:
 - Redevelopment of the 16th Street Mall made a significant step forward by receiving federal approval to advance the project. Construction is expected to begin in 2021.
 - Downtown Denver continues to expand <u>dedicated bike and transit</u> <u>lanes</u> in order to make streets multi-modal. Enhancements are also

- being made along Broadway from Civic Center to Broadway Station.
- RTD has launched a two-year strategic planning initiative, <u>Reimagine</u>
 <u>RTD</u>, and is seeking community input to shape the future of the transit
 agency. RTD is also searching for an interim and permanent <u>general</u>
 <u>manager</u> to lead the agency.
- To advance workforce development efforts, Colorado hospitality leaders Gina and Frank Day made a \$1.5 million gift to the MSU School of Hospitality to establish the <u>Day Leadership Academy</u> and also launch an Industry Professional Hospitality Online Leadership Certificate.
- As a reminder,CU Denver's CityCenter has developed a <u>comprehensive inventory</u> of existing training, certification and educational programs to help our partners recruit and retain employees in the local tourism and hospitality industry. We hope this is a valuable resource and encourage you to share it with your human resources department and other colleagues!
- Denver's <u>B-cycle bike-sharing program is ending</u> and the City will be reassessing scooter, bike and e-bike sharing programs.

STATE NEWS



- The <u>Colorado Transportation Commission</u> announced a project list worth \$1.6B for transportation infrastructure projects statewide over the next 3 years.
- CDOT is expanding its statewide bus service with the launch of <u>Snowstang</u>, which connects skiers in Denver to several ski areas.

FEDERAL NEWS



 Brand USA, the U.S.'s marketing program, was renewed by Congress and signed into law by President Trump, extending the program through 2027. Sincere thanks to members of the Colorado delegation including Representatives DeGette, Perlmutter and Tipton, Senator Bennet, and lead sponsor Senator Gardner, for supporting this important program to increase international visitation.

- Poland has been approved to participate in the U.S. State Department's
 <u>Visa Waiver Program</u> (VWP), joining 38 other countries in this secure travel
 program.
- According to the <u>National Travel and Tourism Office</u>, the U.S. is projected to experience increasing international visitors through 2024, reversing a recent decline.
- The U.S. Travel Association issued this <u>year in review</u> highlighting 2019 efforts.
