

## Swanage Tourism Summary 2023 (Based on post district BH19)



Swanage is situated in the county of Dorset and was part of the former district of Purbeck. The town has a population of approximately 10,000. Tourism plays a significant role in the local economy as demonstrated by the estimates below.

- 970 actual jobs supported by visitor related spend

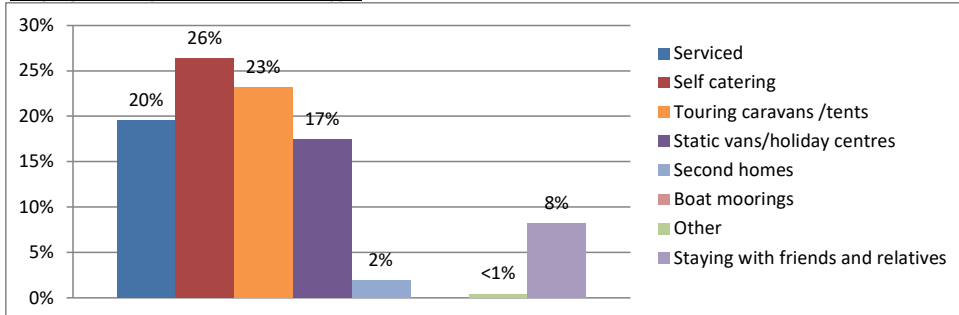

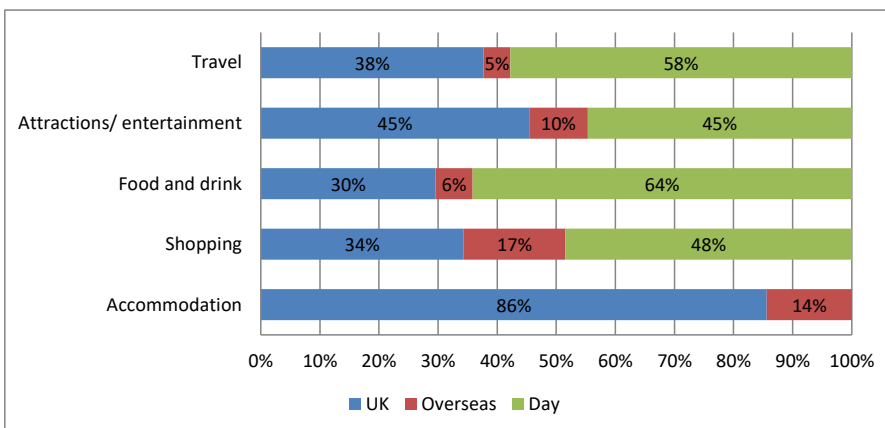
### Staying visits by accommodation type

Induced jobs are those that are supported by the spending of wages by employees in direct and indirect jobs.
