- Tax allocation breakdown:
 - o Tourism Convention & Trade (3.5%) **Restrictive** Funds to the DMO
 - o Non-Restricted Funds (3%) to the City
 - o Tourism Product Development (1.5%) **Restricted** to the city
 - TPD funds could be used for TCT
 - o TCT Funds can only be used for TCT
