

## **DuPage Convention & Visitors Bureau Photo Submission Terms & Conditions**

### **PHOTO SUBMISSION**

No purchase is necessary to enter and win. A purchase will not increase chances of winning. All Federal, State, Local, Municipal Laws and Regulations apply. Void where prohibited. Photo submission sponsored by DuPage Convention & Visitors Bureau and participating members. Photo submission is open to person at least eighteen (18) years old at the time of entry.

### **PRIZES**

Odds of winning depend on the number of eligible entries received. Prizes are non-transferable. No prize substitutions or cash/credit redemptions allowed. All unclaimed prizes are forfeited.

### **ENTRY**

To submit a photo and qualify for a chance to win, an entrant must:

- (1) Engage accordingly to contest social media posts on Facebook and Instagram. Entries will not be valid after photo submission expiration date.
- (2) Drawings will be conducted by DuPage Convention & Visitors Bureau, the judge of the photo submissions, whose decisions are final and binding on all matters related. Any prize notification returned as undeliverable will result in disqualification and an alternate winner will be selected.

### **ELIGIBILITY**

Open to legal residents of the United States (excluding Puerto Rico [and Rhode Island]) who are age eighteen (18) or older at time of entry. Inappropriate submissions are immediately ineligible. Employees of DuPage Convention & Visitors Bureau, participating sponsors, partner municipalities/member businesses and its affiliates, subsidiaries, tenants, advertising and promotional agencies and their respective officers, directors, employees and agents ("Sponsor and its agents") immediate family members and those living in the same household of each are not eligible.
