Plan Commission – Nothing to Report.

Blasting Ordinance/Truck Hauling Ordinance – Hibbard said would be ok to go ahead with truck hauling ordinance.

Land Trust – From Rick Remington – Nothing for the Board to do – Fred signed the letter Rick sent and returned it to him. When Board receives a letter of intent, and then will need a contract once Hibbard reviews.

Roads – updates & decisions – According to Rich Walther we will have money left. Weight ban signs will be permanent signs that all a person has to do is flip up when ban is on or off. Bans will be going on soon. On South Town Hall Rd. by blind spot, someone has dumped garbage again. We need ordinance with fines for dumping garbage. Will also put notification in town crier. MS4 Annual Report – Copy of the one Town of Seymour did was handed to all board members. The annual report will come one year after you apply. We are an urban township – we have to apply. Fred Belay will fill out the notice of intent to apply.

Clerk Contract – Need to have something in writing showing job description and what is expected, will have clerk sign when drafted.
