CALL TO ORDER

The meeting to order 9:02 a.m.

Mr. M. Huber, representing strategic planning consultants, began the slide deck presentation, reporting on the state of the Elkhart County destination. The presentation included reports based on research incorporating economic impact, visitor information, products and services, and visitor/resident survey.

Mr. M. Nichols reported on Elkhart County destination performance and trends. Trends in economic impact, occupancy rates, average daily rate, room demand, and hotel revenue were reviewed over the past

several years. He said that overall Elkhart County outperformed the nation during the COVID pandemic. He said that visitation to Elkhart County was relatively stable in the last half of the decade. He said the present is an opportune time for strategic planning, to consider how to develop destination and drive growth.

Mr. D. Anderson presented visitor profile information based on a survey conducted in early 2022.

Mr. M. Nichols said the question now is how is Elkhart County is positioned to compete in five to 10 years.

Mr. M. Huber said the Elkhart County CVB should consider potential opportunities in group youth sports, leveraging assets such as the aquatics center, rugby grounds, and outdoor recreation with the Pumpkinvine Nature Trail. Mr. D. Anderson said expanding demographic appeal would convert more day visitors to overnight visitors. Mr. D. Anderson presented a review of Elkhart County attractions and how each performed on metrics such as most visited and visitor perceptions. Mr. M. Nichols said there is an opportunity to develop RV-related experiences.

Mr. M. Huber discussed the Elkhart County CVB's role in placemaking and the shift in approach and involvement in development. He presented reports on local resident perception of tourism impact/relevance.

The strategic planning team's next step is public input sessions on April 13 with various local stakeholders to review performance and potential strategies on critical issues.

The meeting adjourned at 11:20 a.m.
