- A signed copy of the Minnesota Revenue Operator Certificate of Compliance form ST19
- A signed copy of the General Release and Hold Harmless Agreement

Our judges will review our first round of jury applications in late December and continue to review applications in batches as they are received. If your application is selected, we will contact you by email and hold your spot for two weeks. Full payment is required and can be submitted by check or credit card. Market Place vendors will also need to submit a certificate of insurance with the City of Ely and Ely Chamber of Commerce listed as additional insured, if selected.
