Lt is important to send quality photos that are a very good representation of your work, which is what the jury will base selection on and, if selected, we will use to promote you. A check or money order for the \$35.00 jury application fee (non-refundable) made payable to **Ely Chamber of Commerce.** Post-dated checks are not accepted. We also accept payment by credit card. A signed copy of the Minnesota Revenue Operator Certificate of Compliance form ST19 A signed copy of the General Release and Hold Harmless Agreement Our judges will review our first round of jury applications in late January and continue to review applications as they are received. If your application is selected, we will contact you by email and hold your spot for two weeks. Full payment is required and can be submitted by check or credit card. Market Place vendors will also need to submit a certificate of insurance with the City of Ely and Ely Chamber of Commerce listed as additional insured, if selected.
