REPORTS.

Kyle Patterson started off by saying that the visitation stats are getting back on track and that most of the days in July are booked and most of August as well. Starting August 23 there is some availability. September still has plenty of spots open. Park is remaining at 60% capacity. Kyle also informed the group that the last minutes spots usually get taken within 2 minutes of them being released. Construction is still being planned and the website will have all updates. They are still seeing significant use in the park before 6am and after 5pm.

Wendy Koeing stated that she is going to resign from her position and appoint Scott Webermeier.

PRESIDENT & CEO.

Eric reported that he attended 35 stakeholder, staff and industry virtual meetings. He also met with the Town, EDC, Chamber and Colorado Tourism Office. Eric spoke about our new Dashboard that each person with VEP will have, It will provide good data. New summer program is designed to increase summer demand and is doing well. Book referrals are also up 30%. Office move was completed and the total cost was about \$3,000. Based on pace reports, it appears that Estes Park lodging is recovering well. Through the Book Direct data, June has 14,000 more referrals and 32,800 in July. Group Sales is pacing ahead of 2019 and continues to work hard on increasing leads. We are reviewing future marketing programs to improve demand for the fall and winter. We are continuing to watch the Larimer County variance and collaborating effectively to the Covid-19 challenges. VEP continues to keep communications via the newsletter and emails regarding Covid-19 updates and guidelines. We are seeing substantial increase in visitation to county and state parks. VEP is still distributing masks and will be replacing the 4th of July banners with Keep NOCO open and Be Kind and Patient. All Board of Directors meetings are announced on the transparency page and newsletters.

PROGRAM REVIEW.

Josh gave us updates on the YoY metrics and users, session and pageviews are all up and session duration is flat to last year. Growth is seen from people actively searching Estes Park. Tracking ahead of 2019 except for the total number of articles.

Eric gave a quick update on Stakeholders team and said that the website sales are fully underway. 85 featured listing sold, 56 enhanced listings sold and 22 display ads sold. Since the visitor center is closed and brochure distribution is not available, we will offer online spotlight advertising content for stakeholders.

Kevin started off with 2020 financial highlights, and spoke on how VEP is continuing to freeze spending for the exception of an Ad buy that was agreed upon prior to Covid-19 and masks. Kevin also said he would provide the 2019 audit for everyone and a copy will be available on the transparency page.
