


Introduction

- All data was collected by the WIDU staff in 1-9 October and then again on 17 November due to rescheduling because of Hurricane Matthew.
- WIDU management estimated **30,000** attendees prior to the event.
- There were **141** completed surveys.
- Using the 30,000 attendees, the Confidence Interval for this presentation with an 141 Sample Size is +/- 8.23%. Because of the size of the sample the Confidence Interval did not meet the "best practice" of +/- 5%.

Overview

- 4 of the 141 completed surveys provided an invalid zip code.
- 91 were from North Carolina and 60 were from more than 100 miles from Fayetteville.
- 21 identified themselves as being here specifically for the event and overnighting in a hotel.



FAYETTEVILLE AREA



Bottom Line

- For the calculations, the FACVB used the agreed upon estimated attendance number provided by the WIDU management of 30,000. The sample size of 141 was considerably less than the required and agreed upon 380 completed surveys necessary to ensure the presentation met "best practices" of +/- 5%, as a result this presentation is at +/- 8.23%.
- **42** surveys were submitted on October 6, **39** surveys on October 7 and 60 November 16, 2016. Of the surveys there were some surveys with duplicate email addresses indicating the same person filled out multiple surveys.
- Room Nights Because the required sample size was significantly below the TDA required amount, the FACVB was unable to accurately project room nights.
- **30** attendees signed up for the FACVB's E-Promotion Program and provided a valid E-mail address.
- 21 people stated they were here specifically for the event and were staying at a hotel. The list of hotels they stayed at are: 16 at Fairfield Inn, 1 at Days Inn, Embassy Suites and "Marriott".
- Official Hotel Pick Up: Final hotel pickup reported by hotels was **210** room nights.
- List of TDA Requirements Not Met:
 - > The required minimum of **380** completed surveys was not met.
