

# Fort Worth Golden Ticket Contest

## Official Rules

**March 4-December 31, 2019**

**1. CONTEST:** The Contest begins 3/4/2019 and ends 12/31/2019 at 11:59PM ("Contest Period"). To enter: fill out entry form, fully complete each question and select one (1) VIP experience. Only entries with all questions answered will be qualified for entry.

**2. REQUIREMENTS:** No purchase or payment is necessary to enter or to win. The Contest is subject to applicable U.S. federal, state, local and municipal laws and regulations.
