



Tourist Development Council (TDC) Meeting Minutes  
Greater Fort Lauderdale Convention and Visitors Bureau  
August 13, 2025, 9:30 am

**1. CALL TO ORDER**

Mayor Beam Furr called the meeting to order at 9:30 am.  
Attendance was taken and a quorum was established.

**2. APPROVAL OF MINUTES**

*A motion to approve the minutes from the meeting of the TDC on May 14, 2025 was made by Tim Petrillo and seconded by Seth Fellman. The minutes were approved without objection.*

**3. TOURIST DEVELOPMENT TAX REPORT | Randall Luechauer, Manager Tourist Development Tax Section**

The GFLCVB portion of the June 2025 reporting period collections totaled \$5,686,634.42, an increase of 5.0% (\$270,231.04) when compared to collections for the same month last year. The GFLCVB portion of FY 2025 revenue collected through the June 2025 reporting period totaled \$68,886,736.93 an increase of 1.0% (\$694,639.23) when compared to collections for the same period last year.

The top ten hotel June 2025 revenue increased an average of 6.9% when compared to the same month last year and represented 19.2% of total revenue collected during the month.

Revenue from all hotels totaled \$6,082,728.00 and represented 71.3% of total revenue collected during the month. Non-hotel revenue totaled \$2,443,963.02 and represented 28.7% of total revenue collected during the month.

FY 2025 hotel revenue collected through the June 2025 reporting period totaled \$76,923,147.13 and represented 74.5% of total revenue collected. Non-hotel revenue collected through the June 2025 reporting period totaled \$26,387,559.70 and represented 25.5% of total revenue collected.

The collection expense for June 2025 was \$85,149.92. The GFLCVB's portion was \$57,762.43 which represents 1.0% of the GFLCVB's monthly reporting period revenue. To date in FY 2025, GFLCVB expenses total \$361,636.05 which represents 0.5% of the GFLCVB reporting period revenue collected through July 31, 2025.

#### **4. CHAIR'S REPORT | Mayor Beam Furr**

Mayor Furr discussed DOGE in Broward County. DOGE has their eye on TDT, DEI, climate change and procurements. DOGE uploaded 50,000 documents from the county. The mayor was very insistent that the TDC's job is to get heads in bed. DOGE brought up the Rose Bowl Parade and the metrics show that it was very worthwhile. The mayor told them that the county just approved funding for the National Championship Orange Bowl which they also consider worthwhile. The county will see in a couple of months what they discover. Discussion ensued.

#### **5. PRESIDENT'S REPORT | Stacy Ritter, CDME, President/CEO, Visit Lauderdale**

##### **Marketing Plan for 2026 | Camila Clark, Sr. VP, Marketing & Communications, Visit Lauderdale**

Ms. Clark discussed the new campaign and positioning. Visit Lauderdale did extensive research and found that people do not choose us as a beach destination. The research found that 40% of non-Florida residents are not familiar with the destination. While 58% of Florida residents who are familiar with the destination would rather visit other places in Florida. Our existing brand platform does not create enough distinction for us. We have a lot of repeat visitors but need to reach new visitors. Visit Lauderdale's audience falls into the luxury travel category. We are leaning into the concept that suggests that being near, in or on the water can make you happier, healthier and more connected and better at what you do. The new tagline is "Never Lose your Splash". We want to invoke a feeling when you see this campaign. Visit Lauderdale will be keeping our original teal color but adding more vibrant colors. The new campaign will be hitting on New Years Eve 2025. Discussion ensued.

*Mayor Josh Levy has made a motion to approve the 2026 Marketing Plan Mayor Tim Petrillo seconded the motion. The motion passed unanimously.*

#### **6. Welcome from City of Ft Lauderdale City Manager | Rickelle Williams, Ft. Lauderdale City Manager**

City Manager Williams has been with the City of Fort Lauderdale for four months coming from the City of Miami Beach where she served as the Economic Development Director, Assistant City Manager and interim City Manager. While working at the City of Miami she oversaw the economic development in the Miami Beach Convention Center. Commissioner Williams understands what the TDC advocates and would like to support Visit Lauderdale. Part of the City of Fort Lauderdale's proposed budget for this year is developing an economic development division. This division will be looking at the city's special events and how we activate the beach and other areas of Ft Lauderdale. We are making sure that we're finding the right balance between quality of life and event impacts. They are also establishing a strategic communications department. Discussion ensued.

## 7. Budget Presentation

### **Elijah Anderson, Program Manager, Broward County Office of Management and Budget**

- a. Mr. Anderson presented the overview of the FY26 Tourist Development Tax Program. TDT revenue collection in FY25 were \$124m and the FY26 Recommended budget for TDT is \$123m. The FY26 recommended Marketing Budget is \$28.2m. The East Expansion of the convention center estimated cost is \$369m and estimated substantial completion is Fall 2025. The Headquarters Hotel which is not funded by TDT dollars has an estimated completion date of Fall 2025 with a total estimated cost of \$669m. Discussion ensued.
- b. **FY 2026 GFLCVB Budget | Stacy Ritter, President / CEO Visit Lauderdale**  
President Ritter discussed Senate Bill 2502. This bill states that local governments are no longer allowed to promote certain things. The most glaring changes in the budget are the LGBTQ budget which has been almost completely cut and the multicultural budget which has been cut in half because we cannot promote concepts of diversity. Accessibility is still in the budget and has been moved into Global Travel Trade which is the leisure market. The LGBTQ Inclusivity and Accessibility VP position which is currently vacant will be redefined. Part of the campaign change is because of Senate Bill 2502. President Ritter explained the sponsorship application process for Sports, Entertainment and Group Sales. If the event is not in the budget, you will need to apply at least 6 months in advance as you must be vetted. Ramola Motwani recused herself from voting due to a conflict of interest (see form 8b below) from voting on this. Discussion ensued.

*Andreas Ioannou made a motion to approve the proposed budgets FY 2025/2026. Tim Petrillo seconded the motion. The motion passed unanimously with one abstention.*

## 8. Broward Cultural Council Member appointment | Stacy Ritter, CDME, President/CEO, Visit Lauderdale

Tim Petrillo was the appointed TDC member on the Broward Cultural Council and stated that due to scheduling conflicts he cannot make these meetings. This is a monthly meeting. Mayor Josh Levy would like to take this position. Discussion ensued.

*Andreas Ioannou made a motion to approve Mayor Josh Levy as the TDC appointee to the Broward Cultural Council. Tim Petrillo seconded the motion. The motion passed unanimously.*

## 9. Motion to Adjourn

*A motion to adjourn the meeting was made by Tim Petrillo and was seconded by Mayor Josh Levy. The meeting was adjourned with no objection at 11:14am.*
