RULES & REGULATIONS

1. Set-up time begins at 1:30 pm. Immediately upon unloading, please remove your vehicle to a parking garage or lot. All vehicles must be off Market Street by 4:30 pm. We suggest you unload, move your car to a parking area, and begin your set-up. That will allow a smoother flow of vehicular traffic in the booth area.
2. You will receive enter/exit information in the coming weeks. Please read it carefully to ensure there is no congestion or unnecessary traffic on each block.
3. No early teardown allowed. Teardown begins at 9 pm
4. Participants are responsible for their display equipment: pop-up tent & weights, tables, chairs, etc. We also strongly encourage seasonal decorations!
5. Absolutely no portable heaters or open-flamed devices are allowed under tents.
6. Only low noise generators will be allowed. PLEASE NOTE: There is no electricity available on the street. NO EXCEPTIONS.
7. There is no lighting at individual booths; we recommend you bring your own lighting – whether it is battery operated or runs off a low-noise generator.
8. All vendors must stay within their booth area. Selling or giving away any items or literature must be done within the confines of your assigned area.
9. Performers must keep at an enjoyable level to avoid interfering with the activities offered at booths located in the immediate vicinity.
10. Entertainers and vendors may not dress as Santa Claus, Kris Kringle, or St. Nicholas. Corning's Gaffer District has contracted for a traditional Santa in Centerway Square in the Crystal House. Let's not confuse the children!
