Qualifying business establishments or trade associations must be located within the Gatlinburg City Limits (Gatlinburg Urban Growth Boundary Area and/or on either side of Buckhorn Road) and provide proof of a Gatlinburg City Business License or an executed Gatlinburg Urban Growth Boundary Area contract with the City of Gatlinburg. Upon the recommendation of Chamber staff and approval of the Board of Directors, the business may hold membership under the classification of Regular Member. Only such members that qualify under this paragraph shall be eliquible for full benefits, to vote on matters pertaining to the management or operation of the Chamber of Commerce, or to hold office therein.
