COLORADO RESTAURANT ASSOCIATION

Colorado is closing restaurants and bars to dine-in statewide. Delivery, take-out, walk-up service, drive-up service, and drive-through service will still be allowed. This measure takes effect immediately, and will begin to be enforced at 8 a.m., March 17, and remains in place for 30 days - through April 17. This comes on the heels of **Denver's closure order**, which is effective from tomorrow at 8 a.m. through May 11.
