

## FIRST SHIP CONTEST! February 1, 2026 Official Rules

1. No purchase necessary to enter or win this giveaway.

2. How to Enter: Go to [www.greenbay.com](http://www.greenbay.com) and complete the official entry form by filling out name, address, e-mail address and home telephone number. (Limit one entry per person.) "Immediate family members" shall mean parents, stepparents, children, step-children, siblings, step-siblings or spouses. Contest will be complete when first ship arrives in Green Bay harbor. All entries become the property of Sponsor(s) and will not be returned. Personal correspondence, telegrams, letters, e-mail, telephone calls or messenger letters regarding the Giveaway will not be returned. In the event of a dispute as to who submitted an email entry, the entry will be deemed submitted by the holder of the e-mail account. Sponsor may prohibit your participation in the Giveaway, if, at their sole discretion, you repeatedly show a disregard for, or attempt to circumvent these Giveaway Official Rules, or act (a) in a manner they determine to be not fair or equitable; (b) with an intent to annoy, threaten or harass any other entrant or the Sponsor; or (c) in any disruptive manner.
