Lodging Revenue

- Second Quarter is up 14.38% with several missing payments.
- It is too early in the third quarter to provide a total.

CVB Employee Updates

- Allen Stebelton, our Digital Strategist, has resigned. His last day on the job was July 28th.

Staff Updates

Trans Am Nationals

- Jessica has been busy working with the Mall at Fairfield Commons and with the planners on the Trans Am event.
- The Trans Am Cruise-In will be held on August 25th in the Mall parking lot across from the Courtyard.
- The Cruise-In will have over ten food trucks, a beer tent, live music from the band Stranger, and a kid's zone with bouncy houses.
- The CVB will have a VIP tent with snacks and beer tickets available.
- The Trans Am car show will be held at the Holiday Inn. Last year, they had over 500 cars registered with 1,500 room nights countywide.
- This year, we are on track to exceed those numbers slightly.

- The cars will start rolling in on August 24th and will be open to the public from August 25th through August 27th.
- This event generates close to \$3 Million in economic impact in our local and surrounding communities.
- This event extends into Tipp City with a cruise-in on Saturday, with 400-plus cars attending.

Advertising, Education & Events
