Approval of Minutes: There were no corrections to the May 6, 2025 minutes. They were approved as presented.

OLD BUSINESS

Zach Wirrig - Director of Public Projects

- Iron Men Apartment Complex Zach stated that the alley in the middle of the property has been vacated along with the alley adjacent to the city parking lot. There are some signs that they may be activating READI 2.0 dollars soon. However, there is no news on the tax credits.
- Liberty Lakes They are continuing to build more houses. They have built four to date. The utilities are complete from the storm water side. Street work will be started soon. There are some repairs needed before the final surface is applied. Duke is working on the street lights and should be done by Thursday. The second phase gas has not started.

NEW BUSINESS

Reedy Financial - June Reporting

Brady Rogers of Reedy Financial presented the June 15 TIF passthrough reporting requirement. Ken Dornich made a motion and Mark Klosterkemper seconded the motion to approve that President Darren Burkhart sign Resolution 2025-12 and supporting letters to show that there will not be any excess assessed value passed through. The motion passed unanimously by roll call vote 5-0.

Zach Wirrig - Director of Public Projects

- Property Marketing Path Forward Zach stated that the contract with the current realtor has expired. No motion to renew the contract was offered by the board. The EDC is working on property marketing on their website.
- North Broadway Extension Zach will reach out to Forge Fitness this week to discuss the right of way needs to be acquired on North Broadway to accommodate the site plan for Forge Fitness.
- INDOT SR46 Lighting Commitment The City is entering into an agreement with INDOT to install city owned lighting on State Road 46. The Council has requested the RDC help with those costs. Estimated project costs are \$932,000. They would like the RDC to contribute up to \$500,000. The contract will go to the City Council at their next meeting. Mark Klosterkemper made a motion and Ken Dornich seconded the motion to commit to the project. The motion passed unanimously by voice vote 5-0.
- Sidewalk Engineering The city has reached out to some engineering firms for new curb and Sidewalk designs on 4th Street from Carver to Lincoln and Moscow Road to Veterans Way. Design work may cost up to \$50,000. Zach will present second quote at the next meeting.
- ullet Hotel Carmichael RAI Site Tour July 10^{TH} Zach will attend the site tour at the Hotel Carmichael in Carmel, IN on July 10.
