Approve Minutes

Minutes from the public hearing on and regular meeting on September 10, 2024, were approved as presented.

Old Business

Fire Chief Nathan Stoermer presented Ordinance 2024-17 for fees and fines for fire inspections for second reading. The entire paragraph on the fireworks portion was removed altogether due to lack of clarity. Motion to approve Ordinance 2024-17 on second reading along with the changes presented made by Kevin Fleetwood, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Clerk Treasurer Amy Borns presented Ordinance 2024-18 City Budget 2025 for second reading. Motion to approve Ordinance 2024-18 on second reading made by Darrell Poling, seconded by Jamie Cain. Roll call vote: Kevin Fleetwood – yes; Dr. Rodney King – yes; Jamie Cain – yes; Darrell Poling – yes; Daryl Tressler – yes; Vietta McKenzie – yes; Mark Carman – yes. Motion passes 7-0.

Borns presented Ordinance 2024-19 Greensburg Community Schools Budget 2025 for second reading. Superintendent Tom Hunter was present to answer any questions on the budget. Motion to approve Ordinance 2024-19 on second reading made by Jamie Cain, seconded by Dr. Rodney King. Roll call vote: Kevin Fleetwood – yes; Dr. Rodney King – yes; Jamie Cain – yes; Darrell Poling – yes; Daryl Tressler – yes; Vietta McKenzie – yes; Mark Carman – yes. Motion passes 7-0.

Borns presented Ordinance 2024-20 City Employee Salary Ordinance 2025 for second reading. Motion to approve Ordinance 2024-20 on second reading made by Jamie Cain, seconded by Kevin Fleetwood. Roll call vote: Kevin Fleetwood – yes; Dr. Rodney King – yes; Jamie Cain – yes; Darrell Poling – yes; Daryl Tressler – yes; Vietta McKenzie – yes; Mark Carman – yes. Motion passes 7-0.

Borns presented Ordinance 2024-21 Elected Officials Salary Ordinance 2025 for second reading. Motion to approve Ordinance 2024-21 on second reading with an amendment to cut the amount on the Mayor's stipend in half made by Jamie Cain, seconded by Kevin Fleetwood. Councilman Dr. Rodney King made statements on his position on this topic. Darrell Poling also made comments on his position on this topic. Roll call vote: Kevin Fleetwood – yes; Dr. Rodney King – yes; Jamie Cain – yes; Darrell Poling – no; Daryl Tressler – yes; Vietta McKenzie – no; Mark Carman – no. Motion passes 4-3.

Borns presented Ordinance 2024-22 Utility Employee Salary Ordinance 2025 for second reading. Motion to approve Ordinance 2024-22 on second reading made by Jamie Cain, seconded by Kevin Fleetwood. Roll call vote: Kevin Fleetwood – yes; Dr. Rodney King – yes; Jamie Cain – yes; Darrell Poling – yes; Daryl Tressler – yes; Vietta McKenzie – yes; Mark Carman – yes. Motion passes 7-0.

New Business

Economic Development Corporation Director Bryan Robbins asked that Resolution 2024-10 be tabled to a later date. Motion to table Resolution 2024-10 made by Jamie Cain, seconded by Kevin Fleetwood. Voice vote, all ayes no nays. Motion passes and topic is tabled.

Personnel Administrator Julie Nobbe presented Ordinance 2024-23 Updates to City of Greensburg Employee Handbook. Nobbe explained the make-up of the handbook committee and the process by which changes were made. Changes include adding in paid parental leave, additional bereavement leave, and allowing employees with less than a year to earn more PTO and use it sooner than 6 months. It was also noted that the Board of Works supported these amendments barring any small changes that might need to be made after Julie speaks with the City's personnel attorney next week. If changes are made, Julie will send a red-lined copy to each Council member with explanations on the changes. Motion to approve Ordinance 2024-23 on first reading made by Rodney King, seconded by Darrell Poling. Voice vote, all ayes no nays. Motion passes.

Director of Public Works Zach Wirrig presented Ordinance 2024-24 Stormwater Fees Schedule. This updates Ordinance 2024-13. Two of the big changes are the inspection fees and the engineering review fees. Motion to approve Ordinance 2024-24 on first reading made by Darrell Poling, seconded by Dr. Rodney King. Voice vote, all ayes no nays. Motion passes.

Council members shared updates on their respective boards and commissions.

Adjourn

Motion to adjourn made by Darrell Poling. Voice vote, all ayes no nays. Motion passes. Meeting adjourned at $7:04\ PM$.
