### Approve Minutes

Motion to approve minutes for both public hearing meetings and the regular meeting on October 10, 2023, made by Darrell Poling, seconded by Rick Emsweller. Voice vote, all ayes no nays. Motion passes.

### Old Business

Building Commissioner Sarah Hamer presented Ordinance 2023-23 for the Unified Development Ordinance with a few amendments from the first reading. Motion to approve Ordinance 2023-23 on second reading with amendments made by Kevin Fleetwood, seconded by Rick Emsweller. Voice vote, all ayes no nays. Motion passes.

### New Business

Matt Mason, of Veridus Group, presented an update on the fire station and street department project. Work on the grading and ground shaping will begin next week. Shaping and framing of the buildings is nearing completion. Issues with the bricks were discovered during a hard rain. The manufacturer is working to correct those issues. The project is still on schedule and on budget.

Police Chief Mike McNealy presented an update on the HVAC improvements happening at the police station. He stated that everything is still within budget and ahead of schedule. He mentioned how pleased they were with Koch Mechanical and their work and communication.

Sarah Hamer, Building Commissioner, presented Ordinance 2023-25 for annexation of City of Greensburg property. This has gone through Plan Commission and received a favorable recommendation to approve this annexation. Motion to approve Ordinance 2023-25 on first reading made by Kevin Fleetwood, seconded by Darrell Poling. Voice vote, all ayes no nays. Motion passes.

Motion to suspend the rules for Ordinance 2023-25 made by Kevin Fleetwood, seconded by Rick Emsweller. Voice vote, all ayes no nays. Motion passes.

Motion to approve Ordinance 2023-25 on second reading made by Kevin Fleetwood, seconded by Darrell Poling. Voice vote, all ayes no nays. Motion passes.

Sarah also presented Ordinance 2023-26 for annexation of 1330 N Anderson Street; several parcels owned by KOVA. This also has passed through Plan Commission with a favorable recommendation Motion to approve Ordinance 2023-26 on first reading made by Rick Emsweller, seconded by Kevin Fleetwood. Voice vote, all ayes no nays. Motion passes.

Motion to suspend the rules for Ordinance 2023-26 made by Rick Emsweller, seconded by Darrell Poling. Voice vote, all ayes no nays. Motion passes.

Motion to approve Ordinance 2023-26 on second reading made by Darrell Poling, seconded by Rick Emsweller. Voice vote, all ayes no nays. Motion passes.

Clerk Treasurer Amy Borns presented Ordinance 2023-27 for an additional appropriation. This is for the General Fund for the fire department to cover payouts of employees who retired and/or left the department. Motion to approve Ordinance 2023-27 on first reading made by Rick Emsweller, seconded by Kevin Fleetwood. Voice vote, all ayes no nays. Motion passes.

Borns also presented Ordinance 2023-24, which is an update of Ordinance 2023-20 for City Employee Salaries. This is to adjust the police salaries as discussed in the October meeting, reducing the total number of officers by two and divide those salaries amongst the remaining positions. Motion to approve Ordinance 2023-24 made by Kevin Fleetwood, seconded by Darrell Poling. Voice vote, all ayes no nays. Motion passes.

Mayor Joshua Marsh presented the Public Meeting Schedule for 2024. No major changes for the upcoming year unless the meeting date falls on a holiday, then it will be held the following day. The Council all agreed with the schedule.

Mayor Marsh also presented the City Office Holiday Closings for 2024. The Council were all in agreement with the closings.

Mayor Marsh announced the Veteran's Day parade on November 11 with the lineup beginning at 10. He also invited everyone to the Holiday Walk for Saturday, December 2, starting at noon.

Council members gave updates of the boards on which they are members.
