Today is Tuesday, January 14, 2025, and the time being 5:30 pm. The meeting of the Greensburg Board of Works is called to order.

New Business

Police Chief Mike McNealy presented information on the Crisis Intervention Team (CIT) program. Sheriff Bill Meyerrose presented information on the program and the funding for it. The County and the Decatur County Community Foundation applied for a Lilly Grant for \$5,000,000, which will help funding this program for an estimated 5-6 years. Jail Commander Mike Eggleston spoke on the planning and implementation of the program. There was discussion held over what the set-up would look like as far as staffing and under which entity (County or City). City Counsel Chris Stephen stated that he and the County's attorney will work together to draw up a Memorandum of Understanding for the next 5-6 years.

Chief McNealy also presented information on the purchase of a new K-9 officer. This purchase was made with the help of the Sheriff's department. Chief McNealy will bring the officer to next month's meeting to be introduced.

Clerk Treasurer Amy Borns presented an update on the Greensburg Fire Department 150th Anniversary Book. 145 books have either been donated or sold. 55 books are still available for sale.

Director of Public Projects Zach Wirrig announced that there were no proposals for the old fire station. Jack Woods of the Veridus Group gave some information on possibilities of why there were no proposals for the site. He also talked about what might be the next possible steps, including taking another look at the feedback and possibly sending it to the RDC to look at.

Wirrig presented a proposal from Michael Baker (INDOT's designer for water main and sewer improvements) for the sewer line on the east main portion of the Washington Street project. Motion to approve the Revision Number 1 from Michael Baker as presented, pending the Water Board approval next month, made by Glenn Tebbe, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Wirrig also presented the contract with Strand Associates for Park Road (Phases 1-4) for sewer engineering. This plan is made to coincide with the phases of Park Road and to work alongside USI on the different phases. Motion to approve the contract with Strand Associates for the sewer engineering along Park Road made by Glenn Tebbe, seconded by Lauren Barnhorst. Voice vote, all ayes no nays. Motion passes.

Wirrig gave an update on the Washington Street project. The work has slowed down due to the weather, but Schutte has been out there working as much as they can on the project.

Mayor Marsh took a moment to acknowledge the Street Department on all their work and hours cleaning up the streets from the snowstorm.

Motion to approve the claims as presented made by Robin Meyer, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.
