Plan Commission Public Hearing Minutes

The Planning Commission Public Hearing is called to order by President, Kevin Fleetwood at 7:18 pm.

Annexation with R-4 zoning for property located at 1200 S. Co. Rd. 60 E. Chris Stephen gave a brief explanation of one hundred percent voluntary annexation for contiguous property and how this board will make a zoning recommendation to the City Council.

Mindy Westrick Brown of Faegre Drinker Biddle & Reath, 300 N. Meridian St. Suite 2500, Indianapolis, IN represented Christian and Karen Rust. An R-4 zoning is being requested. Legal counsel intends to prepare written commitments for the project and stated there are no intentions of developing multifamily or a mobile home park. They are looking to develop senior housing and would like to model Crown Point with duplexes for seniors.

Erin McCullough, 814 E. Mill Creek Rd. S., spoke about property values, crime, and traffic.

Lori Garringer, 1212 W. Rebecca Parkway, commented on R-4 zoning, utilities, and infrastructure.

Charles Simmons, 821 E. Mill Creek Rd. S., brought a petition with 106 signatures and a list of concerns from residents in Mill Ridge Estates. The petition was added as part of the record.

Jody Westerfeld, 820 E. Mill Creek Rd S., discussed St. Mary's students and parishners, Mill Ridge Estates and adjacent properties, and the senior population.

Jackie Michell, 1339 S. Co. Rd. 60 E., spoke of infrastructure, the blind hill on Millhousen Rd., and safety.



Ryan Walsman, 1521 S. Hunters Dr., discussed his kid's safety, traffic, infrastructure, aesthetics, and the private school.

Scott Mangles, 919 E. South Ridge Dr., wants R-1 zoning.

Sandy Nieman, 206 E. Co. Rd. 300 S., is concerned about traffic.
