2. **Land Acquisition Grant FY 2023 (AIP 22)** – FAA closeout letter requested.
3. **Land Acquisition Grant FY 2024 (AIP23)** – FAA closeout letter requested.
4. **Land Acquisition Grant FY 2025 (AIP 25)** – Grant Application has been submitted to the FAA.

5. **Bipartisan Infrastructure Law (BIL) (AIP24, AIP26) -**

- Phase 1 grant for the apron has been received.
- Phases 2 and 3 grant applications have been submitted to the FAA.
- The total project cost will require FY2026 BIL funds (Ph. 4),
