Today is Tuesday, March 11, 2025, and the time being 5:30 pm. The meeting of the Greensburg Board of Works is called to order.

Minutes from the regular meeting from February 11, 2025, and executive session from February 27, 2025, approved as presented.

Deena Hamer of the YMCA requested a police presence at the intersection of Washington and Lincoln for the Tree City Rolling Tour on June 28, 2025, from 7-10 am. Mayor asked about alternative parking for the bikes. Hamer mentioned several funeral homes and churches she has been in contact with who have given permission for the use of their lots. The Mayor requested that the organizers stop painting the road surface for signage. Chalk that washes off is acceptable. This restriction applies to roads within the city limits. Motion to approve the road usage for June 28 made by Glenn Tebbe, seconded by Jamie Cain. Voice vote, all ayes non nays. Motion passes.

Sarah Walton from the Girl Scouts requested road intersection usage for the Cookie Crumble 5K. This event will be April 12th at Rebekah Park. The Girl Scouts provide their own safety team members for the crossings, and Adam's Volunteer Fire Department will work the crosswalks. Motion of support for the event made by Jamie Cain, seconded by Robin Meyer. Voice vote, all ayes non nays. Motion passes.

Fire Chief Nathan Stoermer presented bids for the surplus supplies from the old fire station. Motion to approve the bids as presented was made by Glenn Tebbe, seconded by Lauren Barnhorst. Voice vote, all ayes non nays. Motion passes.

Assistant Police Chief Derek Fasnacht requested road closures for the community cookouts and National Night Out. Road closures requested are for Maureen and Israel on May 8 and East St on June 5. National Night out will be August 14. Motion to approve all street closures on dates and times as presented was made by Jamie Cain, seconded by Robin Meyer. Voice vote, all ayes non nays. Motion passes.

Assistant Chief Fasnacht presented a promotion for Officer Jacob Mays to Sergeant.

The Meritorious Award was presented to Officer Allison Reismiller for closing a high-profile case in 2024. Assistant Chief Fasnacht stated, "Officer Reismiller's diligence and dedication to this case will bring justice to numerous victims and families throughout several communities."

Director of Public Projects Zach Wirrig presented an engineering agreement with HNTB for the lift station at North Broadway. This goes along with the current water project. HNTB will design a new lift station to further the goal of realigning North Broadway. The main goal of the project is to go from 10th Street across the bypass and get that fixed. Motion to approve the engineering agreement with HNTB made by Robin Meyer, seconded by Lauren Barnhorst. Voice vote, all ayes non nays. Motion passes.

Wirrig presented the Christopher B Burke GIS on-call service agreement. This would be on an as-needed basis. Motion to approve the contract as presented made by Glenn Tebbe, seconded by Jamie Cain. Voice vote, all ayes non nays. Motion passes.

Wirrig explained that the outfall pipe from the retention pond at Liberty Circle is plugged, creating more water retention in the pond than is needed. Wirrig requested that this topic be tabled until he and Burke can do more research on the City's responsibility for these issues. Motion to table made by Jamie Cain, seconded by Lauren Barnhorst. Voice vote, all ayes non nays. Motion passes.

Wirrig gave updates on local projects. He also announced that the City received the CCMG 2025-1 award.

Motion to approve claims as presented made by Glenn Tebbe, seconded by Robin Meyer. Voice vote, all ayes non nays. Motion passes.

Adjourn
