Today is Tuesday, March 12, 2024, and the time being 5:30 pm. The meeting of the Greensburg Board of Works is called to order. At this time, please silence all electronic devices.

Approve Minutes

Mayor Marsh presented minutes from the February 21st regular meeting. Minutes were approved as presented.

Old Business

At the last meeting, the Board tabled the fire contract with Washington Township. Changes were made to the contract as requested by Board members. The red-lined version has now been sent to the Washington Township Board for them to look over. Motion to table this until after the Washington Township Board has had a chance to respond made by Glenn Tebbe, seconded by Robin Meyer. Voice vote, all ayes no nays. Motion passes.

New Business

Matt Mason from Veridus Group presented his monthly report on the municipal project. Concrete work is being done on the backside of the fire department, as well as windows being installed. At the street department, painting is near completion on the interior. Substantial completion is still set for the end of May, with move-in scheduled for mid-June.

Police Chief Mike McNealy requested a status change for GPD K9 Hercules. K9 Hercules is starting to show signs of osteoarthritis in his rear hips. It is recommended by his veterinarian that he retire from the force. Chief McNealy requested that K9 Hercules be released into Handler Hershberger's family for the remainder of his life. Motion to approve the retirement and release K9 Hercules to Handler Hershberger's family made by Lindsay Jobe, seconded by Glenn Tebbe. Voice vote, all ayes no nays. Motion passes.

Fire Chief Nathan Stoermer requested an interview meeting time with the Board for two candidates for one open position. March 28 at 5:30 pm was agreed upon by the Board.

Utilities Manager Donna Lecher requested a sewer leak adjustment. The adjustment was for \$1,219.25. Motion to approve the adjustment as presented made by Robin Meyer, seconded by Lindsay Jobe. Voice vote, all ayes no nays. Motion passes.

Wastewater Superintendent Zeke Smith gave an update on the South Vine Street project. The kickoff meeting will be tomorrow (Wednesday, March 13). Projected completion date set for July-August.

Superintendent Smith also presented quotes for an equipment building and concrete work. It is for a 50'x80' building. Roger Linkmeyer and Bubba Wilson (current employees with Wastewater) have already done quite a bit of work within the building structure, including installing all of the electrical, saving the City money on this project. Three quotes came in for the concrete from Corbins Excavation, Homan Inc, and Johannigman Excavating. Motion to award the concrete work to Corbin's Excavation made by Glenn Tebbe, seconded by Robin Meyer. Voice vote, all ayes no nays. Motion passes.

Street Commissioner Mark Klosterkemper presented an update on the Request for Proposals (RFP's) for Phase 4 of Park Road. Last week, the City was awarded Phase 4 by INDOT for the Park Road project. This RFP is for the design work for Phase 4.

Mayor Marsh also presented Change Order #1 from USI for the East Trail. It is an amendment to the agreement we already have with them, allowing the City to create an extension to the walking trail in Rebekah Park. Motion to approve Change Order #1 made by Lindsay Jobe, seconded by Robin Meyer. Voice vote, all ayes no nays. Motion passes.

Mayor Joshua Marsh gave an update on the status and planning of the Tree City Total Solar Eclipse set for April 8, 2024. He pointed out many informational items that have already been mailed out the City of Greensburg residents, as well as a hotline number for people to call for more information.

Motion to approve claims as presented made by Glenn Tebbe, seconded by Lindsay Jobe. Voice vote, all ayes no nays. Motion passes.

Next month will be the last meeting for Lindsay Jobe. Mayor Marsh acknowledged her contribution to the Board of Works and thanked her for her time.
