### **New Business**

Jill Pratt, Decatur County Public Library, requested a road closure for Touch-a-Tractor activity to be held at the library on June 29, 2022, from 1:00 - 3:30 pm. Partnering with Power of the Past for part of the Summer Reading Program, they will need to close down the section of Washington Street behind the library. Mayor Marsh explained that part of Washington Street is privately owned by the nursing home back in that area. Street Commissioner Mark Klosterkemper has offered to go with Jill to the nursing home to speak with them about closing the road so long as the Board approves. Motion to close the road made by Glenn Tebbe, seconded by Karen D. Rust. Voice vote all ayes, no nays. Motion passed.

Jessica Hadler from St. Mary's Festival requested a road closure for 'On Eagles Wings 5K' on August 27, 2022, from 8:30 am until about 10:30 am. Motion to close the roads and use tape to mark the route made by Glenn Tebbe, seconded by Rodney King. Voice vote all ayes, no nays. Motion passed.

Jarrad Klosterkemper, owner of Tree City Brewery, was in attendance to request an addition of outdoor cafe seating at the brewery. A diagram was sent ahead to the Board. 3-4 foot fence will surround the area, 2 tables will be on either side of the exterior door, and the fence will be at least 6 feet from the curb. Building

Concern was raised about homeowners being able to get in and out of their driveways. Chief McNealy assured the Board that arrangements will be made with residents beforehand. Motion to approve both closures as presented made by Rodney King, seconded by Jamie Cain. Voice vote all ayes, no nays. Motion passed.

Chief McNealy mentioned to the Board that the end of the year report will be ready for next month's meeting, if not before.

Mayor Joshua Marsh presented (MS4 Compliance) Burke Engineering Contract for Wastewater Superintendent Zeke Smith who could not be at the meeting. The work through this contract will help our wastewater treatment facility transition from Rule 13 permit to IDEM's new MS4 General Permit. Motion to approve contract with Burke made by Glenn, seconded by Karen D. Rust. Voice vote all ayes, no nays. Motion passed.

Mark Klosterkemper, Street Commissioner, requested a disposal of a salt spreader. Asked to take what is left of the salt spreader to River Metals. Motion to approve disposal made by Rodney King, seconded by Jamie Cain. Voice vote all ayes, no nays. Motion passed.

Ron May, City Engineer, brought to the Board Resolution 2022-01, which approves the stormwater credit manual. Motion to approve the credit manual made by Glenn Tebbe, seconded by Rodney King. Voice vote all ayes, no nays. Motion passed. Public meetings to answer questions for the new stormwater utility will be held the evening of Wednesday, March 23, 2022.

Mayor Joshua Marsh presented Change Order 16 for Building Renovation for three items, all of which are credited back to the City for \$8265.74. Motion to approve Change Order 16 made by Karen D. Rust, seconded by Jamie Cain. Voice vote all ayes, no nays. Motion passed.

Motion to approve the claims as presented made by Karen D. Rust, seconded by Rodney King. Voice vote all ayes, no nays. Motion passed.
