### Approve Minutes

Motion to approve minutes from the February 8, 2022, meeting made by Jamie Cain, seconded by Vietta McKenzie. Voice vote all ayes, no nays. Motion passed.

### **Old Business**

Ron May, City Engineer, presented Ordinance 2022-04 to amend 2021-15 for Stormwater Utility on second reading. Public education hearings on this new utility will be held at City Hall on March 23. Commercial 4 pm, Residential 6 pm. Motion to approve 2022-4 on second reading made by Jamie, seconded by Darrell. Voice vote all ayes, no nays. Motion passed.

### **New Business**

Mike McNealy, Police Chief, reported that the Greensburg end of year report will be presented to the Council either before or at next month's meeting.

Amy Borns, City Clerk Treasurer, presented Ordinance 2022-05 for additional appropriation of \$550,000 for Greensburg Community Schools. Motion to approve Ordinance 2022-05 on first reading made by Darrell Poling, seconded by Rick Emsweller. Voice vote all ayes, no nays. Motion passed.

Mark Klosterkemper, Street Commissioner, announced Heavy Trash week. He proposed to have it May 16-20, 2022. This allows them to have some part-time summer help to assist in this week. Motion to approve the presented dates of May 16-20, 2022, for Heavy Trash week made by Jamie Cain, seconded by Vietta McKenzie. Voice vote all ayes, no nays. Motion passed.

Councilman Kevin Fleetwood brought forth a question on a possible ordinance change in the future. Ordinance 2019-40 allows UTV's to drive on the city streets but not state highways. However, according to Indiana Code 9-21-3-3.3, and samples from other communities, there is a possibility of amending the current ordinance to allow UTV's to drive on state highways that are within the city limits. Councilman Fleetwood asked if the other Council members would be open to discussing that amendment at a future meeting, all agreed to being open to the discussion.
