Call to Order: President Bill Ernstes called the meeting to order at 6:00 pm.

Roll Call: Board members present were: Bill Ernstes, Jon Dooley, Kevin Whipple, Gary Bailey, and Deborah Potter. Airport Manager Jerry Scheidler were also present. John Feister of BF&S was absent. Judy Curd performed the duties of recording secretary.

Agenda Approval: President Bill Ernstes presented the April 3, 2025 agenda for approval. Gary Bailey made a motion and Jon Dooley seconded the motion to approve the agenda as presented. The motion passed unanimously by voice vote 5-0.

Minutes – The minutes of the March 6 , 2025 regular board meeting were presented. A motion was made by Jon Dooley and seconded by Deborah Potter to approve the March 6, 2025 regular minutes as published. The motion passed unanimously by voice vote 5-0.

BF&S – Next Step of Construction –

BF&S Project Updates -

1. **Runway 1-19 Paving and Lighting (AIP 20 and AIP 21)** - FAA Closeout Letter requested.
2. **Land Acquisition Grant FY 2023 (AIP 22)** – FAA closeout letter requested.
3. **Land Acquisition Grant FY 2024 (AIP23)** – FAA closeout letter requested.

4. **Land Acquisition Grant FY 2025 (AIP 26)** – Grant Application was submitted to the FAA on 2/10/25.

5. **Infrastructure Investment and Jobs Act (IIJA) (BIL) (AIP 24,25, 27)**
 - Phase 1 (AIP 24) grant for the apron has been received
 - Phases 2 (AIP 25) and 3 (AIP 27 NPE) grant applications have been submitted to the FAA.
 - The total project cost will require FY2026 BIL funds (Ph. 4).
 - Contractor intends to start construction mid-to-late May.

Airport Manager (Jerry Scheidler)

Jerry reported that the owner of the security camera supplier came out to inspect the cameras to see if they had been installed correctly. The cameras were originally installed only 8 ft. off the ground. The owner agreed that cameras had been installed too low and he stated that he will return soon to raise them to an appropriate height. He also stated that there are no motion sensors on the cameras.

Approve Payment of Bills – Jon Dooley made a motion and Deborah Potter seconded the motion to approve the payment of the bills as listed. This would exclude \$85.66 listed on the water bill for Pirate Park. The motion passed unanimously by voice vote 5-0.
