Today is Tuesday, April 8, 2025, and the time being 5:30 pm. The meeting of the Greensburg Board of Works is called to order.

Minutes from the March 11 meeting and the April 7 executive session were approved as presented.

New Business

Members of the Mayor's Youth Council requested road closures and public safety assistance for their 5K Chalk Run. The event will be held out at Rebekah Park on June 14 from 9 am to 11:30 am. The Greensburg Police and Fire Department have both agreed to assist in the event. Carmen Ripberger, Brinly Jameson, Declan Bruns, and Wade Schutte were the presenters. Motion to approve the road closures as presented made by Glenn Tebbe, seconded by Lauren Barnhorst. Voice vote, all ayes no nays. Motion passes.

Mark Carman from the Tree City Fall Festival Committee requested road closures for September 18 starting at 6 pm for the corner of Broadway and Washington to get the stage set up, and then closures of Franklin, Broadway, and Washington around the Square for both Friday and Saturday September 19-20. They also requested the Greensburg Police Department for security, which was agreed upon by Police Chief Mike McNealy. Motion to approve closures as presented made by Jamie Cain, seconded by Lauren Barnhorst. Voice vote, all ayes no nays. Motion passes.

Chris Ramey of Ramey Consulting requested road closures for a cruise-in on September 7 from 10 am to 3 pm. The request is the closure of Broadway from Main Street to Washington Street. Motion to approve the road closures made by Robin Meyer, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Whitney Koelling for ARa was present to discuss the Owner-Occupied Rehabilitation Grant that was awarded to the City. Her request is that the Board approve the Mayor to have preauthorization to sign off

on projects so that projects can be started on time and not wait for the monthly meetings. Motion to approve Mayor sign-off on contracts as approved by ARa and authorize payments made by Jamie Cain, seconded by Glenn Tebbe. Voice vote, all ayes no nays. Motion passes.

Washington Township Trustee Bev Rivera, President of the Washington Township Board Randy Hoeing, and attorney Lora Williams were present to discuss the contract between the City and Washington Township for fire protection. A decision was made to have an executive session to discuss the contract at a later date. Trustee Rivera stressed her appreciation of the partnership of City and the Township with the fire department. Motion to table the contract made by Jamie Cain, seconded by Lauren Barnhorst. Voice vote, all ayes no nays. Motion passes.

Fire Chief Nathan Stoermer made a request to make two conditional offers of employment, one to Candidate 1 and the other to Candidate 3. Motion to approve the conditional offers with the amendment that the memorandum also be corrected to say Candidates 1 and three made by Glenn Tebbe, seconded by Robin Meyer. Voice vote, all ayes no nays. Motion passes.

Director of Public Projects Zach Wirrig gave updates on the local projects, including Washington Street and the trail out at Rebekah Park.

Mayor Joshua Marsh presented an amended employee payout. Motion to approve the amended payout as presented made by Robin Meyer, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.

Wastewater Superintendent Joe Cain gave an update to the Board about activities that happened over the weekend due to the torrential rains from Thursday to Sunday. The Board and Mr. Cain wanted to make sure the department is recognized for the work they did and the many hours they put in over the weekend.

Mayor Marsh and Police Chief Mike McNealy swore in two new officers to the Greensburg Police Department, Curtis Keppel and Paige Parsons.

Motion to approve claims as presented made by Glenn Tebbe, seconded by Jamie Cain. Voice vote, all ayes no nays. Motion passes.
