Mayor Marsh presented an update for the Municipal Complex Project. Many finishing details are being done, including drywalling and painting. The original project is still within budget. The past two months the Council has approved additional projects, which has amended the GMP.

Building Commissioner Sarah Hamer presented Ordinance 2024-06 for rezoning of 218 S East Street. This will be rezoned from B-2 to B-1. It has already gone before Plan Commission with a favorable

Mark Roszell of (1055 E Israel St, Greensburg) requested to speak during the meeting. He raised concerns over the D.O.R.A. project, the funds for the Eclipse project, and the new welcome signs coming into the City. Mayor Marsh responded to each of those items. Dr. Rodney King also responded.

Mayor Marsh gave an update on the successful Tree City Total Solar Eclipse event at Pirate Park. It was a great day and a great event, with many positive reviews from visitors about our community.






